**Skin contact:** If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. **TWA** - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

**Personal protection equipment:** E: OVERALLS, SAFETY SHOES, SAFETY GLASSES, GLOVES, DUST MASK.

Wear overalls, safety glasses and impervious gloves. Avoid generating and inhaling dusts. If dust exists, wear dust mask/respirator meeting the requirements of AS/NZS 1715 and AS/NZS 1716. Available information suggests that gloves made from nitrile rubber should be suitable for intermittent contact. However, due to variations in glove construction and local conditions, the user should make a final assessment. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storing or re-using.

**Hygiene measures:** Keep away from food, drink and animal feeding stuffs. When using do not eat, drink or smoke. Wash hands prior to eating, drinking or smoking. Avoid contact with skin and eyes and inhalation of dust. Ensure that eyewash stations and safety showers are close to the workstation location.
