## Section 4. First aid measures

### Large spill

## Section 7. Handling and storage

### Precautions for safe handling

#### Protective measures

Avoid exposure - obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not breathe dust.
